Noteworthy this month:

A report from Navigant estimates over \$960 Billion will be spent by Commercial and Public Building owners on energy efficiency retrofit projects by 2023.

An Energy Vortex article noted GM is bringing on line 3 acres of PV at two Michigan plants, working towards its stated goal of 125 MW globally installed PV capacity by 2020.

Another article notes that LADWP (Nation's largest municipal utility serving 3.9 Million customers) has announced it is increasing its energy efficiency targets again to 15% reduction in energy consumption by 2020 from 2010 baseline – saving the city \$775 Million in utility bills according to the NRDC.

New York Times article shares that New York City Mayor Bill de Blasio's administration is planning to overhaul energy-efficiency standards of all the city's public buildings and to pressure private landlords to make similar improvements; the initiative is part of a pledge, which will be announced at start of United Nations Climate Summit, to decrease greenhouse gas emissions by 80 percent by 2050 from 2005 levels.

Energy Efficiency Opportunities in the Grow Industry. Energy Efficiency Opportunities in the Grow Industry: A local grower (**Devin Liles** of The Farm), grow energy consultant (Brad Queen of Cube Resources), and a Boulder County grow regulator agent (Ron Flax) will provide a general discussion on the grow industry and how the current state of this industry are impacting energy policies and utility load as well as where the energy efficiency opportunities lie.

Private Sector Energy Performance Contracting (EPC) Program. Jeanna Paluzzi, EPC Program Manager for the Colorado Energy Office (CEO), will provide an overview of a pilot program to leverage the CEO's public sector EPC experience in the private sector. Forum participants are encouraged to provide input on design of a possible program to build on these private sector results.

Net metering and Value of the Electrical Grid. Beth Chacon with Xcel Energy's Environmental and Public Policy group will speak about Xcel Energy's view of solar in general, net metering, and the value of the grid.

Colorado Energy Office Keynote. Jeff Ackermann, Director of the CEO will talk about CEO programs and the future of energy policy in Colorado.

Cybersecurity of Building Automation Systems (BAS) and Networks. Noah Welshans, Technology Sales Development Engineer with Johnson Controls will discuss cybersecurity issues associated with building automation systems and networks critical to energy efficiency.

Small to Medium Size Building Automation. Jim Payne from the U.S. Department of Energy's Building Technology Office (DOE) will discuss efforts to develop an open source Building Automation Solution suitable for small to medium size commercial buildings. This is a space that does not have a significant presence from the major BAS players, and could yield significant energy savings with BAS implementation.

Energy/water Efficiency in Craft Brewing. Brad Queen, of Cube Resources, will give a general overview of the brewing industry specifically related to where energy is being used and what the opportunities for energy efficiency are in the industry. Odell Brewing and Powder Keg Brewing will discuss energy efficiency projects implemented in their brewery and discuss the results.

Noah Welshans Noah is currently responsible for leading sales development and adoption of technology innovations and cloud analytics utilizing building and equipment data for business decisions. Noah has worked in both a technician and sales engineer roles for Johnson Controls in Milwaukee, Denver, and Kansas City.

Emerging Technologies. David Podorson, an analyst for eSource, will discuss several new technologies including: evaporative cooling retrofits to RTUs, liquid submerged servers, cloud thermostats, zoning technology, rooftop retrofit VSDs, LED lighting, daylighting film, and commercial laundry applications.
